Year in review



- Released in third-quarter 2023, the 24th edition of Annual Manufacturers' Shipments Survey Report offers the industry a data source to estimate market size in terms of dollars and units for 54 product lines.
- NTEA, in collaboration with Commercial Truck Trader and S&P Global Mobility, issued the fall 2023 U.S. Commercial Vehicle Market Report. This industry resource delves into the details, data and trends around the life cycle of commercial vehicles — from chassis shipments to truck registration to later stages when used vehicles are resold.
- Available to survey participants in the first and third quarters, Business Conditions Survey Report helps distributors and manufacturers better anticipate the upcoming market and gain insights into expectations regarding hiring, sales levels and business strategies.
- NTEA held its 2023 Executive Leadership Summit in September in Plymouth, Michigan offering a forum to explore important commercial vehicle trends, forecasts and insights.
- NTEA hosted the upfitter community and commercial vehicle chassis manufacturer technical and engineering experts at Commercial Vehicle Upfitting Summit, Oct. 3–4, 2023, at Kalahari Resorts & Conventions in Sandusky, Ohio.
- In conjunction with Commercial Vehicle Upfitting Summit in October, NTEA released the first edition of the OEM Chassis Considerations Guide. This comprehensive guidebook helps support chassis product development for a broad array of commercial vehicle applications.
- NTEA, in collaboration with Lincoln Electric Company and National Coalition of Certification Centers (NC3), offered two more train-the-trainer sessions in October 2023 and April 2024 for the Work Truck Industry Welder Certification Program. This initiative provides industry companies with access to a consistent training curriculum they can utilize to train welders within their organizations.
- NTEA hosted Work Truck Week 2024 at Indiana Convention Center, March 5–8, 2024.
- Held during Work Truck Week 2024, Green Truck Summit featured intensive programs on clean energy trends for commercial vehicles and operational insights for vocational truck fleets.
- In March 2024, NTEA released the 17th edition of Truck Equipment Handbook, the work truck industry's most comprehensive pocket guide for commercial vehicle components and equipment.
- In 2023, NTEA continued its support for legislation to repeal the 12% Federal Excise Tax on heavy trucks and trailers.

MVP recognizes eligible companies in the work truck industry for outstanding business practices and successful implementation of quality standards (222 companies held MVP member designation upon conclusion of the 2023–2024 fiscal year). Association members are encouraged to apply for consideration. Candidates must provide documentation that

they meet or exceed a given set of criteria. Once qualified, companies receive MVP member status for a three-year term. In order to renew, MVP members must again document conformance, ensuring their ongoing commitment to professionalism, industry knowledge and high performance.

Government advocacy

NTEA maintains a government relations department and satellite offices in Washington, DC,

and Ottawa, Ontario. We are committed to protecting and advancing member interests by actively working with Congress, the White House, Parliament and federal agencies. Dedicated NTEA staff monitor and report Congressional, Parliamentary and regulatory agency activities, as well as advocate on behalf of the work truck industry. The Association works diligently to ensure fair representation regarding all legislative and regulatory issues.

2023-2024 fiscal year highlights

Emissions

As governments pursue regulations to create a zero-emission vehicle (ZEV) future, this year has demonstrated many of the challenges to this transition. NTEA continues expressing to legislators and regulators that future ZEV work trucks must be available, capable and cost-effective.

The Environmental Protection Agency (EPA) released proposed Phase III greenhouse gas regulations in 2023 and issued final rules in 2024 for light-, medium- and heavy-duty vehicles. NTEA was active in these rulemakings, and the final rules recognize differences between work trucks, passenger cars and long-haul tractors.

In California, NTEA is working to educate California Air Resources Board (CARB) officials on the present and future challenges of their Advanced Clean Truck (ACT) and Advanced Clean Fleet (ACF) rules that contain ZEV sales and purchase mandates.

In Canada, NTEA has engaged with Environment and Climate Change Canada (ECCC) regarding proposed ZEV sales mandates and Phase III of their Heavy-Duty Vehicle (HDV) and Engine Emission regulations. NTEA also sits on two working groups on ZEV policies: 1) ECCC's HD ZEV Regulatory Consultation Working Group; and 2) Charging Infrastructure for Medium- and Heavy-Duty Vehicles (MHDVs) working group under the Government of Canada's ZEV Council.

FET

NTEA has begun positioning Federal Excise Tax (FET) repeal as part of the transition to ZEVs. Based on technology that could eventually eliminate gas and diesel as a transportation fuel, the tax revenue generated must be reevaluated. NTEA expects Congress to consider tax legislation in 2025 that would provide an appropriate avenue to address the FET issue.

Catalytic converter theft

Theft of these emission control systems has been a major problem for the commercial vehicle industry. NTEA supports legislation to address the issue. The Preventing Auto Recycling Theft (PART) Act would require parts marking and record keeping that would reduce thefts. NTEA is working to include specific truck parts such as diesel particulate filters and diesel oxidation catalysts into the legislation.

AEB/ADAS

National Highway Traffic Safety Administration (NHTSA) and Federal Motor Carrier Safety Administration (FMCSA) jointly proposed automatic emergency braking (AEB) rules for heavy trucks. NTEA is working with the agencies to understand how the bodies and equipment installed on the chassis may conflict with originally installed sensors. NTEA is similarly working with Transport Canada on these issues.



NTEA hosts strategic events that bring the industry together for product unveilings, networking and important chassis updates.

Work Truck Week[®] continues to grow. A verified 15,790 industry professionals from 29 countries and all 50 U.S. states gathered March 5–8 at Indiana Convention Center in Indianapolis for Work Truck Week 2024, breaking last year's attendance record of 14,885. Work Truck Show exhibit space was sold out,

with 536 companies filling the exhibit hall and New Exhibitor Pavilion with the latest commercial vehicles, equipment and technology. Work Truck Week 2025 will be held March 4–7, 2025, at Indiana Convention Center.

NTEA held its 2023 Executive Leadership Summit in September — offering a forum to explore important commercial vehicle trends, forecasts and insights. The next event, scheduled Sept. 24, 2024, returns to Saint John's Resort in Plymouth, Michigan.

In October, NTEA brought together the upfitter community with commercial vehicle chassis manufacturer technical and engineering experts in Sandusky, Ohio, for Commercial Vehicle Upfitting Summit. The 2024 event, scheduled Oct. 15–16, will return to Kalahari Resorts & Conventions in Sandusky.




Industry profile

North American commercial truck and truck equipment industry sales expectations for 2024 are cautiously optimistic. The current forecast calls for 2% growth (in unit terms), but that will depend on market activity improving in the second half of the year as the first half started slowly, which isn't surprising since sales growth trended down throughout second-half 2023. Through the first two months of 2024, U.S./Mexico sales have declined 5.4% relative to 2023. They are still rising in Canada, though, at a 7.2% rate.

Total industry sales reached \$167.5 billion in 2023. Based on the unit forecast noted above, and inflation expectations, the total is expected to grow to \$175.9 billion in 2024. If truck demand or inflation grows more than expected, that number will be higher. The primary downside risk is slower U.S. economic growth than anticipated. Consensus economic forecasts of U.S. economic activity currently call for growth of about 1.5% this year and 2.0% in 2025.







Membership overview
